In Burgundy, the Vins de Village are wines that come from grapes grown in the territory of certain villages which give their name to the appellation, such as Volnay, Pommard, Meursault or Vosne-Romanée. In a similar manner, the rural towns of Lunlunta, Vista Flores, San Carlos, Tupungato, Agrelo and La Consulta lend their names to the beautiful historic vineyards that surround them.

Wines labeled from a particular appellation/IG must be sourced 100% from vineyards in the IG.
